## EXIT DESTINATIONS

Exit destinations are used to identify where a client will stay just after exiting a project for purposes of tracking and outcome measurement.

HOMELESS DESTINATIONS	HUD EXPLANATION
Place not meant for habitation	Examples - a vehicle, an abandoned building, bus/train/subway station/airport or anywhere outside
Emergency shelter, including hotel or motel paid for with emergency shelter voucher, or RHY-funded Host Home shelter	ESG Emergency Shelter • HOPWA Hotel/Motel or Short Term Housing • RHY BCP shelter or RHY-funded Host Home shelter • VA HCHV Community Contract Emergency Housing • Locally-funded shelters
Safe Haven	CoC Safe Haven • VA Community Contract Safe Haven • Locally-funded Safe Haven type projects
INSTITUTIONAL STAYS	HUD EXPLANATION
Foster care home or foster care group home	Foster Care -A situation in which for a period of time a child lives with and is cared for by people who are not the child's parent(s). • Foster group home: A facility of any capacity which provide 24-hour nonmedical care and supervision to children in a structured environment, with such services provided at least in part by staff employed by the licensee.
Hospital or other residential nonpsychiatric medical facility	Residential mental health treatment environments generally provide longer- term care for individuals. Most residential treatment settings provide medical care but are designed to be more comfortable and less like a hospital ward than inpatient hospitals
Jail, prison, or juvenile detention facility	Client is not receiving services from project and/or not housed with voucher anymore due to being placed in jail, prison or juvenile detention facility.
Long-term care facility or nursing home	A long-term care home, sometimes called a nursing home, is a place where seniors can live and receive help with their daily activities, such as eating or bathing. Long-term care homes also provide 24-hour nursing and personal care, and therefore are best suited for people who have difficulty directing their own care.
Psychiatric hospital or other psychiatric facility	Psychiatric hospitals, also known as mental health units or behavioral health units, are hospitals or wards specializing in the treatment of serious mental disorders
Substance abuse treatment facility or detox center	Health facilities providing therapy and/or rehabilitation for substance- dependent individuals
TEMPORARY OR PERMANENT HOUSING DESTINATIONS	HUD EXPLANATION
Residential or halfway house with no homeless criteria	A sober living or other residential project with no lease or rights of tenancy, with or without time limits

Host home (noncrisis)	
Staying or living with friends, temporary tenure (e.g. room, apartment or house)	Guaranteed temporary housing with client(s) friends
Staying or living with family, temporary tenure (e.g. room, apartment or house)	Guaranteed temporary housing with client(s) family
Staying or living with family, permanent tenure	Guaranteed permanent housing with client(s) family
Staying or living with friends, permanent tenure	Guaranteed permanent housing with client(s) friends
Moved from one HOPWA funded project to HOPWA PH	Limited to use by HOPWA-funded projects
Moved from one HOPWA funded project to HOPWA TH	Limited to use by HOPWA-funded projects
Rental by client, with GPD TIP housing subsidy	Transition in Place housing is a housing model where Veterans are provided time-limited transitional housing assistance with the lease converting to the Veteran as their permanent housing.
Rental by client, with VASH housing subsidy	Veterans and their households only
Permanent housing (other than RRH) for formerly homeless persons	• CoC Permanent Supportive Housing • HOPWA facility/TBRA permanent housing (for Destination: when moving from non- HOPWA projects)
Rental by client, with RRH or equivalent subsidy	Use this response category as a Destination only if the client is moving directly into a unit. • CoC Rapid ReHousing • ESG Rapid ReHousing • VA SSVF Rapid Re- Housing • Locally-funded Rapid ReHousing
Rental by client, with Housing Choice Voucher (HCV) (tenant or project based)	Includes HCV with no paired services • Use for clients that have been housed with an Emergency Housing Voucher (EHV)
Rental by client in a public housing unit	Public housing - decent and safe rental housing for eligible low-income families, the elderly, and persons with disabilities. Public housing comes in all sizes and types, from scattered single-family houses to high rise apartments. Managed by Public Housing Authorities.
Rental by client, no ongoing housing subsidy	When a client leaves an RRH project maintaining (or moving to) a rental that they will pay for on their own (without a subsidy of any kind) you should select Rental by Client, no ongoing housing subsidy.

Rental by client, with other ongoing housing subsidy	Any subsidized rental housing other than CoC PSH, HOPWA PH, RRH, GPD TIP, or VASH. Includes legacy SRO and Pay For Success
Owned by client, with ongoing housing subsidy	Used if client(s) have left your project to housing they have purchased with some kind of subsidy
Owned by client, no ongoing housing subsidy	Used if client(s) have left your project to housing they have purchased
No exit interview completed	This will be considered "missing data" for data quality and reporting purposes
Other	Any response of "Other" in Destination will not count in any HMIS based reporting as a positive outcome. Review the above list carefully to determine if any option above is a reasonable match.
Deceased	Used if client has passed away while in project
Client doesn't know	Any response of "Client doesn't know" in Destination will not count in any HMIS based reporting as a positive outcome. Review the above list carefully to determine if any option above is a reasonable match.
Client refused	Any response of "Client refused" in Destination will not count in any HMIS based reporting as a positive outcome. Review the above list carefully to determine if any option above is a reasonable match.
Data not collected	Any response of "Data not collected" in Destination will count as missing data.
